They will be advised to follow '<i>Stay at home: guidance for households with possible or confirmed coronavirus (COVID-19) infection</i>', which sets out that they must self-isolate for at least 10 days and should arrange to have a PCR test to see if they have coronavirus (COVID-19). Procedures have been created and established between staff and will be shared with the students during their return to school.
