Staying COVID Secure – Our Commitment

- ✓ We recognise the risk posed by Coronavirus (COVID-19) to our staff, pupils and their families. Control measures to minimise the risk of infection and the transmission of the virus are provided in this Risk Assessment.

In response to Trafford having the third highest Covid rates across Greater Manchester with increasing cases in 5-15 year olds, children and young people aged between the ages of 5 and 16 should now be advised to stay at home when a sibling or household member tests positive for COVID-19 (via either a PCR or Lateral Flow test).

On day 2/3 following the onset of symptoms in the household (or test date if the positive case had no symptoms), the close contact child should get a PCR test. If this is negative, they can return to the setting, but should isolate again immediately and get another test if they develop symptoms of COVID-19 at a later date. If they are of secondary school age, following a negative PCR test they should take a daily LFD test before they come into school for 10 days from the initial onset of symptoms in a household member.

Any parents or carers who still want their child to continue to attend school have the right to send their child into the setting. In these situations, we strongly advise the precautions as described above should be taken but we recognise that this cannot be enforced.

Fully vaccinated staff who are close contacts to a positive PCR Covid case in their household should take daily LFT tests for 10 days. It is also recommended they wear face coverings in communal areas at school. Unvaccinated staff must isolate at home for 10 days by law if there is a case in their household.
