## **Bursary Policy**

#### Introduction

The 16-19 Bursary Fund was introduced by the Government as a replacement for the previous EMA scheme (Education Maintenance Allowance). The purpose of the Bursary is to support students within the Sixth Form by meeting the needs of young people facing the greatest financial barriers to participation.

#### Aim for the Bursary

The aim of the Bursary is to remove barriers to learning; therefore monies must be spent on items such as:

- Travel expenses, e.g. bus passes
- Supplying study guides and books
- Essential items relating to their Sixth Form studies e.g. lunches and clothing
- Internet connection at home, by providing an internet dongle
- Providing financial support for any academic trips and activities

### Who is eligible to receive the Bursary?

A young person under 19 on 31 August in the academic year in which they start their programme of study.

#### (Vulnerable groups)

This bursary is upto £1,200 a year and is paid monthly. It may be awarded to:

- Young people aged 16 and 17 in Local Authority care
- Care leavers aged 16, 17 and 18
- Young people aged 16, 17 and 18 who are in receipt of income support or Universal Credit because they are financially supporting themselves and anyone who is dependent on them and living with them such as a child or partner
- Disabled young people in receipt of Employment Support Allowance who are also in receipt of Disability Living Allowance, or Personal Independence Payment in their own name

Students who meet the criteria for bursaries for vulnerable groups are not automatically entitled to a bursary if they do not have financial needs and/or their financial needs are covered from other sources.



#### **Discretionary Bursary**

This bursary may be available to Altrincham College Sixth Form students who are eligible for free school meals, which the school will be aware of, or who live in a household whose family income is £25,000 per annum or less and/or whose parents/carers may be in receipt of any of the following:

- Income Support or Universal Credit
- Income Based Job Seekers Allowance
- Employment Support Allowance
- Incapacity Allowance
- Any other benefit

Any young person could receive a bursary, as long as they attend provision that is:

- Publicly funded; and
- Subject to inspection by a public body that assures quality (e.g. Ofsted)

# How will the Bursary be spent?

The Headteacher, in conjunction with the Business Manager will determine the students most in need of additional support.

There will be a review of the student's circumstances throughout each academic year to identify anyone who might become eligible during an academic year and a proportion of the fund will be set aside for this eventuality.

## **Monitoring spending**

The Bursary spending will be monitored by the School Business Manager.

A record of all spending will be kept, providing evidence of how the money was spent and which students the money has supported.

#### Bursary payments:

Bursary money is linked to attendance and behaviour and payment will be stopped immediately if attendance reaches 85% or below, or if a student accrues 20 lates to Sixth Form in one academic year. If the minimum attendance level is not reached students will be required to meet with the Head of Sixth Form to discuss the reasons.
